Dear Mr. Karayiannis,

Thank you very much for your letter enclosing details of your village in Cyprus which has been under occupation since the Turkish invasion 15 years ago.

My constituency of London North (Barnet, Enfield and Haringey) does, as I'm sure you know, contain the largest concentration of Cypriots outside of Cyprus. I have been actively working with and for the Cypriot community on the Cyprus problem for the last 18 months.

I am, therefore, very aware of the tragedy of villagers who have been forced out of their homes and have pledged my support in the European Parliament to do what I can to help towards a united Cyprus once more.

I am currently very actively involved in trying to force the Turkish Government to ensure the immediate and unconditional release of the 100 Greek Cypriot women, the Bishop of Kitium and his fellow priest and the journalists who were arrested when they crossed the Green Line on the night of the 19th July.

I hope that the above will show you that I am indeed a friend of Cyprus and keen to do all that I can for a much needed solution.

I have already written to President Vassilou and to Greek Cypriots living in Bristol to express my clear view that I do not agree that Turkey should be accepted as a Member of the European Community until the points made in the second paragraph of your letter have been dealt with and I also feel that Turkey's record on human rights does not merit the description of the Turkish Republic as being a Democracy.

I hope that Cyprus will, in due course, apply to be a Member of the European Community and that its application will facilitate a settlement on the Island. Please keep me informed of any developments which take place.
